

CLUB OFFICER TRAINING

More than 40 members and leaders attended training for 4-H club officers on October 20th at the 4-H Office. They were asked to write statements about what leadership meant to them and about a goal they personally wanted to achieve. They also broke into groups to discuss the responsibilities of their particular office.

Additionally, they practiced how to run effective club meetings using Parliamentary Procedure and learned how important communication is in building a team after the Marysville and East Nicolaus FFA officer teams demonstrated these useful tools.

Overall, the feedback from both members and leaders was positive. "The team building;" "Being able to see what being a officer is all about;" "Marysville High School FFA team on Parli Pro;" and "Met new people" were just some of the things they liked best based on the comments stated on the evaluations they completed at the end of the day.

Best of all, they overwhelmingly responded that they thought they were able to be a better officer because of what they learned at the workshop, and are equipped to fulfill the 4-H motto, "To make the best better."

Speaking of making the best better, please think about how to incorporate the training, including setting goals for your club using the SMART technique, (Specific, Measurable, Attainable, Realistic, and Time-lined) when completing your club's Program Planning Guide. Remember, you don't have to check everything in the guide.

Also, practice the Parliamentary Procedure techniques that were demonstrated and to effectively facilitate club and committee meetings. Also, be sure to record the decisions that were made at each meeting so they are complete and accurate in the meeting minutes. This includes the decisions made about how to raise funds and spend funds.

There is an insert of a fictitious club's meeting minutes to give you an example of each motion made from approving the previous meeting's minutes and treasurer's report, to what kind of fundraisers members decide to do and what they are raising the funds for, to what events and activities club members plan to participate in.

Lastly, it's very important to keep accurate records of how much income was brought in and what expenses were paid. Include all original receipts and if you lose a receipt, complete a "Declaration of Lost Evidence" form that can be found on the local website.

For more information on how to do your job best, talk with your Club Leader/s and consider having a designated Officer's Advisor. Best wishes!

SAN DIEGO WILD FIRES AFFECT 4-H FAMILIES

All of us have heard the news about the devastation that recent wild fires have created in San Diego and surrounding counties. The following is an excerpt from an e-mail from Hogan Tong, 4-H Program Rep. in San Diego County.

"Reports and stories have been coming in from all over the county now. Our fair grounds in Del Mar was what some horse folks called "controlled chaos" at best. Thousands of horses were sheltered there including llamas, alpacas, chickens, ducks, cats, dogs, a zebra, and a monkey.

Our East County Fair is housed at the Eastern County Rodeo Grounds and we learned that they needed experienced hands to help out with the animals there. We sent out word and now that emergency shelter is fully staffed with 4-H members caring for the animals.

Sadly 4-H families have lost homes. Two of our leaders who have been with us for 25 plus years a piece lost their homes. We are attempting to reach out to them, but communication is still sporadic in the affected areas. We want them to know that we are here to help.

We are accepting donations directly. Please make checks out to San Diego 4-H Leaders' Council. The Fire Recovery Fund will be used to help our 4-H families affected by the disaster. Hopefully, we can ease some of the stress by assisting with supplies for animals, replacing materials for projects, and replacing lost equipment for affected clubs.

Please consider this to be one of your club's community service projects this year as well as individually making a donation as you can. Thank you.

The Sutter/Yuba Counties 4-H Program's Record Book/ Star Rank Judging Committee will judge Record Books for star ranks on **Saturday**, **January 12**, **2008**. So, start preparing your books now to earn the next star to place on your hat as a mark of accomplishing the goals you set in developing your citizenship, leadership and life skills.

<u>PLEASE NOTE</u>: Attendance at 80% or more Community Club <u>and</u> Project meetings is still required for submitting a Record Book for any type of judging.

- 4-H Projects Completed: It is a requirement that an "Annual Project Report" be completed and included in your folder for each project you complete per year, including Jr./Teen Leader Reports.
- 2. <u>4-H Project Skill Activities</u>: Report the number of events where you showed or exhibited your 4-H project at the project, club, county or state level, or where you participated in a judging contest.
- 3. <u>4-H Events Attended</u>: Achievement Night; Club Officers Training; Craft Day; Harvest Festival; Sectional Leaders' Council meeting; Equine Advisory Committee meeting; Presentation Day (not as a presenter).
- Leadership Development: Represented club at Bi-County Council meeting; Served as Washington Focus delegate; Planned window display for National 4-H Week contest; Chaired committee conducting hands-on activity at Harvest Festival.
- Citizenship/Community Service: Led 4-H pledge at County Council meeting; Picked and donated pumpkins to Harvest Festival; Served as 4-H escort at Farm Day; Staffed booth at Harvest Festival.
- 6. <u>Communication Skills</u>: Wrote article about Achievement Night and submitted to Appeal Democrat and/or Clover Chatter (not as part of your job as Reporter); Prepared PowerPoint presentation as part of National 4-H Week promotion; Gave speech at school about 4-H; Made presentation at project, club, state, or sectional level.
- 7. Honors and Recognition: 100% Attendance pin; Proficiency Pin; Camp attendance pin; Clean Barn award; Honor Roll at school; State Record Book Medalist or Winner; Emerald Star.
- <u>Lifestyle Activities</u>: Working at a job not related to 4-H; Drummer in school jazz band; On school sports team.

POLICY REMINDERS AND UPDATES

• 311: Volunteer Break in Service

4-H volunteers returning to the 4-H YDP after a year or more break in service must repeat the Volunteer appointment process, including a new fingerprint clearance & orientation.

• 703.1: Budget Planning

All 4-H YDP VMOs/Councils and units/clubs will prepare an annual program budget to establish allocation of financial resources to fulfill program needs.

Budget management is a primary responsibility of Council and 4-H YDP club officers. Thus officers are responsible for ensuring that members are kept abreast of the budget targets as compared to the actual expenditures. If there are deviations from the planned budget, officers are obligated to inform the members to ensure that there is full agreement, support, and approval on any changes.

The method of fund raising and intended use of funds must be included in the annual budget proposal, and reviewed and approved by the UCCE County Director or designee. Raising funds with no specific 4-H YDP program or purpose is not allowed.

703.2B 3b: Raffles Not Permitted

4-H participants (members and leaders) cannot sell raffle tickets to fundraise for their club or for other organizations. A raffle is an activity that requires no skill in order to win a prize. Prizes are awarded through the purchase of chances.

Proposition 17 sets forth rules that govern lotteries and charitable raffles in California. Public non-profit agencies, such as the University of California 4-H YDP, are not legally permitted to conduct lotteries, raffles, bingo or other games of chance.

Additionally, all fundraising activities are to be reviewed by county office 4H YDP staff or the County Director. These activities should further the educational and research goals of the 4-H Youth Development Program.

Up Close and Personal with Jeanne Christenson and Liz Romness

processes in a hands-on way. The program also provides an opportunity for 4-H members and leaders to visit with their state and federal elected officials to discuss issues affecting their communities.
