POLICY REMINDERS AND UPDATES

Cross Clubbing for Projects

A 4-H member who is currently enrolled in a Community Club and who wishes to enroll in a project not offered by the "home" club, may under the following conditions, "crossclub" to another club offering the desired project.

- The member must be currently enrolled, with fees paid, at the "home" club and enrolled in at least one project in the "home" club.
- ✓ The desired project SHOULD NOT be offered at the "home" club. (There are few circumstances that will warrant county approval if the "home" club already offers the desired project.)
- The member and parents MUST get the (cross-club) project leader's permission to enroll the member in the second club's project and complete the cross clubbing contract.
- The member must agree to follow the requirements of participation and completion set by the cross club project leader. If the member fails to follow such requirements their contract may be revoked pending county office review.


