Club Record Books Due October 1, 2003 4-H Office

Now that the 2002-2003 4-H year is over, it's time for Club Officers to wrap up some important details.

Treasurer

The Treasurer Books are due to the 4-H Office to meet the University of California regulations. As outlined in the manual you need to complete the Treasurer's Manual, including the final Treasurer's Report. Your club books must be audited before they are submitted to the 4-H Office. The Audit Committee must fill in the back outside cover of your Treasurer's Book with the information required. Submission of all financial information is **MANDATORY**.

Secretary

Take an inventory of the property owned by your 4-H club. In order for your club to receive a Seal for the charter, the Secretary's Book must be turned in to the 4-H Office.

2003-2004 4-H Enrollment DUE: November 1, 2003

- All enrollment forms must be submitted to the Community Club Leader. No forms turned in by individuals will be accepted at the 4-H Office.
- All enrollment forms are due to the 4-H Office by November 1, 2003.

There is no longer an additional charge for members or adults enrolled in the Horse Project!

Membership Age Eligibility

Membership in the 4-H Program is accepted according to the following categories:

PRIMARY: K-3rd grade – Must be 5 years old or in Kindergarten as of January 1, 2004.

JUNIOR: 4th – 6th grade – Must be 9 years old or in 4th grade as of January 1, 2004.

SENIOR: 9th grade and over – Have not reached the age of 19 years old by December 31, 2003.

NOTE: For home schooled children, only the age criteria will apply.

REMINDER: Primary members are eligible to enroll in ONLY the following animal projects: dogs, rabbits, cavies, cats, poultry and pygmy goats. Youth must be 9 years old or in the 4th grade as of January 1, 2004 to enroll in a large animal project (sheep, swine, beef, goats, dairy cow, and horse).

FOR PROJECT LEADERS Project Requirements

To make the 4-H experience a learning experience as well as a rewarding experience there are certain requirements that need to be met by all leaders and members.

Project leaders are required to hold a minimum of five (5) meetings or 10 hours of instruction. Project members are required to attend 80% of these meetings to be eligible for fairs participation and awards. times, there are circumstances when it is not possible to attend meetings. The project member is responsible for notifying the project leader to inform him/her of this and make alternative arrangements. Many project leaders will arrange for "make-up" meetings or activities.

Developing Project Goals

Leaders sometimes ask, "Is there anything else we should be covering in this project this year?" And new leaders ask, "What should we be covering?"

The answer lays in the project objectives. The objectives for youth project work can be found in the booklet called "California 4-H Incentives and Recognition Program Objectives". If your club leader doesn't have a copy, copies are available from the 4-H office.

This document describes the scope of project knowledge the youth member should be developing – consistent with their years of experience in the project.

At county, regional and state record book judging, this is used as the guideline to assess and compare the members' development and experiences.

Most of the objectives guide a member in developing four ways:

- Knowledge and application of some body of guiding principles, scientific research and the application of these to the area of work, such as methods and practices.
- 2) Skill development (actual doing).
- Developing capability to apply this body of knowledge into meaningful opportunities and career choices.
- 4) Grasping the economics of the activity.

For example, let's look at the Sheep Project objectives. You can apply the same thinking to your project's objectives.

- "Learn the basic principles of animal science by owning and/or caring for and keeping records on one or more head of livestock." Note: the member does not have to own an animal IF he/she is closely involved with at least one animal's care and record keeping.
- 2. "Demonstrate knowledge of sound breeding, feeding, and management practices. Members beyond the first year are expected to be gaining knowledge of 'breeding, feeding, and management practices'." Does this mean they should own a breeding animal? Not necessarily - BUT they need to be working closely with a breeding animal. The member should also be learning the effects of different feeds. They should know "good" and "bad" animal management practices and WHY.
- "Identify types and grades of animals and fleece to employ efficient marketing practices." They need to learn to judge and grade animals and fleece AND to understand how these affect usability and marketability.

- 4. "Identify quality in wholesale and retail cuts of animals and animal products and understand their relationship to management practices." Advance members should be taught what can be done to maximize the return on their economic and time investment in this whole process.
- "Learn the value of scientific research and its influence on animals, the meat industry, and the fiber industry." Your advance members should know the leading edge research in their project area.

But what if you don't have all these answers? That's where your county resource leaders, the staff of the university, and industry specialists can help.

Do you need to do it all? NO!! Ask your Jr./Teen Leaders to arrange a speaker. Go on a field trip, take a ranch tour, or get a feed producer to speak. Use your imagination and HAVE FUN!

"Life after Budget Cuts": A Message from the State Director August 2003

Dear 4-H Youth & Volunteers;

Throughout the spring and summer, so many of you have been involved in efforts to let legislators and the public know about the proposed budget cuts and their potential impact on Cooperative Extension and the 4-H Youth Development Program. Your efforts have been phenomenal! You have done a tremendous job of raising public awareness of our program and the impact we make on youth and communities. All over the state, volunteers and youth have conducted powerful letter and fax campaigns. We've also seen many letters to the editor, newspaper articles, and television spots that showcased the wonderful contributions the program makes, and the challenges we face with budget cuts. The cuts to Cooperative Extension and the 4-H YDP could have been much worse, if it hadn't been for all of your efforts, and the increased visibility of the 4-H YDP. Thank you so much for your tremendous support and hard work. I am constantly awed and inspired by your commitment and passion for 4-H!

With the passage of the state budget, we know that Cooperative Extension is faced with a 25% budget cut. There are still many questions that need to be addressed about where those cuts will be made, but we do know that Vice President Reg Gomes has made county-based programs (including the 4-H YDP) a top priority. While we know that the counties will still face some cuts, we are also encouraged by the fact that the work that happens at the local level has been recognized and valued.

In order to preserve county-based programs as much as possible, administration and statewide units will take a greater share of cuts (this includes the State 4-H Office and the California 4-H Foundation). The State Office and Foundation will eliminate three positions and assume additional cuts in operating support. However, in spite of these cuts, we plan to continue seeking new ways to support the work that happens locally. We will be doing some strategic planning in early September to address the question, "Given the current reality of our state staff and budget, how can we be of most support to counties, both programmatically and financially!" Our planning will be guided by the Mission and Direction core values and program criteria. We will have to eliminate some of our activities, and possibly add new areas of focus. If you would like to provide input, please share your thoughts with the 4-H Advisor or Program Representative in your county, who can send it along to us.

We will share the results of this strategic planning with you, when it's completed, and will disseminate updated contact information for the State 4-H Office and 4-H Foundation. I am confident that our program will remain strong and effective, and that we will be able to continue "engaging youth in reaching their fullest potential"!
